<p><b>I AGREE</b> in consideration for my participation in this Competition HITS Desert Circuit to the following:</p> <p><b>I AGREE</b> that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longueur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor.
