Staff will also maintain online attendance records and note work completed, progress, and challenges. All attendance records will be communicated on a daily basis with parents/guardians and on a weekly basis with the student's school. At the conclusion of each 1:1 session, the Blue Ribbon Scholars learning coach will fill out a progress report that details specific topics covered, areas for improvement, and any practice work assigned. Hours of Operation (Study Hall)

Elementary students:

Monday to Thursday: 1pm – 4pm; individual sessions available on request, see next section (1:1 sessions). Minimum attendance: 2 days per week.

Grades 6-12 students:

Monday to Thursday: 8:30am – 12pm; individual sessions available on request, see next section (1:1 sessions). Minimum attendance: 2 days per week.

Hours of Operation (1:1 Sessions)

Every reasonable effort will be made to accommodate individual, 1:1 tutoring sessions at mutually agreeable and convenient times for students and learning coaches. **Sessions may be scheduled between the hours of 8am to 8pm, Monday to Saturday, and 8am to 6pm on Sundays, year-round.** Winter circuit tutoring may occur at HITS Post Time Farm or another public location, or via Zoom online videoconferencing.

Student and Parent Responsibility

It is incumbent upon students and parents to provide timely access to coursework and school contact information in order for Blue Ribbon Scholars to provide excellent academic services to our students. All students enrolled in Study Hall must provide syllabi and / or curricula in advance of sessions conducted by Blue Ribbon Scholars.

Students enrolled with Blue Ribbon Scholars should come prepared to Study Hall and 1:1 sessions with the required academic work to be completed. Parents are responsible for ensuring that their students have access to the assignments required by their school.

Academic Honesty

Students and parents acknowledge that Blue Ribbon Scholars services are provided for the purpose of facilitating learning, not cheating. Payment

Enrollment Terms & Conditions

- 1. The Parties:** This agreement is between the customer (meaning the parent/guardian/adult student) who has signed the Student Enrollment Application and Blue Ribbon Scholars LLC.
- 2. Term:** The term commences on the date that both parties have signed this agreement and will terminate after the fulfillment of the sessions with Blue Ribbon Scholars LLC indicated on the Student Enrollment Application, subject to renewal and/or modification in accordance with paragraph 4.
- 3. Notices:** Anywhere in Blue Ribbon Scholars LLC documentation: "Written notice" means (i) an email notice to info@blueribbonscholars.com.
- 4. Renewal:** The customer and Blue Ribbon Scholars LLC agree that this Enrollment Terms of Service may be renewed, extended, or otherwise modified, and that the customer's credit card may be charged accordingly, by verbal or email notice with electronic signature (customer's name as it appears in the Student Enrollment Application), set forth within an email notice, and preceded and followed by slashes; for example, /John Doe/. You must have a computer with hardware and software capable of receiving emails, downloading and reading documents, and storing them on your computer.
- 5. Guardian:** It is recommended that a guardian be present during each Blue Ribbon Scholars LLC study hall or 1:1 session with any minor (any minor is a student under the age of 18). A guardian means a parent over the age of 18). Given that a guardian's presence may not be practicable for every Blue Ribbon Scholars LLC session, the guardian agrees to accept Blue Ribbon Scholars LLC session reports as documentation of work completed with a tutor. Reasonable effort, as defined by Blue Ribbon Scholars LLC, will be made to recap each session but Blue Ribbon Scholars LLC is not responsible for errors or omissions in session reporting.
- 6. Tutors:** It is understood that Blue Ribbon Scholars LLC will do all it can to find a suitable 1:1 tutor (for students enrolled in the 1:1 tutoring program) in a reasonable time solely defined by Blue Ribbon Scholars LLC once deposit has been cleared. 1:1 Tutor availability varies depending on season, subject, and student availability. All tutors are screened. Any concerns that a customer may have with a tutor match should be shared as soon as concern is noted and discussed with Blue Ribbon Scholars LLC to allow opportunity for resolution.
- 7. Tutor Solicitation:** Blue Ribbon Scholars LLC is required to ensure in writing that Tutors it has contracted are not allowed to accept direct employment or referrals from Blue Ribbon Scholars LLC customers. Solicitation of services with a Blue Ribbon Scholars LLC tutor, except through Blue Ribbon Scholars LLC, is strictly prohibited.
- 8. Cancellation Policy:** The customer must contact Blue Ribbon Scholars LLC to arrange for rescheduling. We require a minimum of twenty-four (24) hours prior notice to reschedule a study hall or 1:1 session. The customer will be charged if sufficient notice is not provided. The authority to cancel/reschedule sessions is only allowed by the customer (parent/guardian/adult student).
- 9. Non-sufficient funds (NSF payments):** An NSF payment may result in the termination of this agreement at the sole discretion of Blue Ribbon Scholars LLC. A replacement payment by cash, certified or cashiers' check or money order plus an NSF fee of \$25 dollars must be received by Blue Ribbon Scholars LLC must be received by Blue Ribbon Scholars LLC within five (5) business days after the customer receives an NSF notification. Declined credit cards and stopped payments shall be considered as NSF payments.
- 10. Blue Ribbon Scholars LLC Exclusive Right to Terminate:** This agreement may be terminated at any time if, in Blue Ribbon Scholars' judgment, the tutoring is being conducted under circumstances not conducive to the student's success. This includes, but is not limited to, abusive, hostile, or unsafe environments; unreasonable expectations placed upon the tutor; and any attempts by the customer or student to compromise the tutor's integrity. If Blue Ribbon Scholars LLC terminates the enrollment, all paid unused 1:1 session and study hall time will be refunded to the client.
- 11. Blue Ribbon Scholars LLC Guarantee:** Parents, guardians, and adults may request change of tutors within reason, as defined by Blue Ribbon Scholars LLC. Used 1:1 sessions and study hall time are not refundable. Within 15 days of enrollment, with written notice, the account can be closed, and the closing balance determined as follows: Total monies received minus value of used hours, minus a \$100 administrative fee. A negative balance is due in full to Blue Ribbon Scholars LLC at the time of cancellation. Blue Ribbon Scholars LLC will refund any remaining positive balance within 30 days of cancellation.
